

Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

In my opinion the Annual Governance Statement is not consistent with the Council's financial management and governance arrangements for the year:

- The Annual Governance Statement records that the Council has in place proper arrangements for the approval of accounts. The Accounts and Audit (Wales) Regulations 2014 require the Responsible Financial Officer (RFO) certifies the accounting statement before it is approved by the Council. However, the RFO certified the accounting statement 5 days after the Council approved the accounting statement.
- The Regulations require the Council to approve the accounts by 30 June. Page 3 of the return states the Council approved the accounts on 11 November 2020.
- The Council does not publish on its website the information it is required to publish electronically by the Local Government (Democracy) (Wales) Act 2013. Therefore, I am unable to confirm whether or not the Council did in fact approve the accounts

Other matters arising and recommendations

There are no further matters that I wish to draw to the Council's attention.
