### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.



## Auditor General's report

### Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis for Qualification

#### Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Councils financial transactions and financial position for the year:

- The Council did not maintain proper accounting records during the year
- The Council has restated the prior year comparative accounts but has not provided an adequate explanation for the changes
- The Council was unable to provide adequate explanations for variances between the 2018-29 and 2019-20 accounts.

#### Annual Government Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's financial management and governance arrangements for the year;

- The Council did not maintain an adequate system of internal control as set out in the internal audit report
- I have been unable to establish if the Council properly appointed its former clerk and properly operated PAYE

### Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

#### Annual Governance Statement

The proforma Annual Governance Statement sets out the minimum standards of good governance that the Council should adopt. I draw attention to the Council's negative responses to the assertions. On the basis of the action already taken by the Council to address the deficiencies it identified, I have concluded that no further report is required. However, the Council needs to ensure that it addresses all the deficiencies it has identified. I will follow up on the Council's progress at future audits.

There are no further matters that I wish to draw to the Council's attention.
